Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> • Full legal name, date of birth and social security number • Information about your financial status • Account balance, assets and transaction history • Wire Transfer Instructions • Biometric Data <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. However, you can contact us at any time to limit our sharing.</p>

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Evergreen Wealth Advisors chooses to share; and whether you can limit this sharing.

How does Evergreen Wealth Advisors protect my personal information?	<p>We maintain physical, electronic, and procedural safeguards that comply with federal standards to protect your nonpublic personal information.</p> <p>Our Privacy Policy serves as a standard for all Evergreen Wealth Advisors employees for collection, use, retention, and security of individual customer information.</p>
How does Evergreen Wealth Advisors collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • Complete an Investment Advisory Agreement • Open an account or perform transactions • Make a wire transfer or tell us where to send money • Make deposits or withdrawals from your account • Provide account information, orally and in writing • Give us your contact information • Provide your government-issued identification • Link Account Information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes – information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>If you have a joint account, each accountholder may make their own choice. Any accountholder's choice will apply only to that accountholder, unless you tell us otherwise.</p>

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Evergreen Wealth Corporation. Evergreen Wealth Advisors is a wholly owned subsidiary of Evergreen Wealth Corporation.</i> • <i>Evergreen.ai. Evergreen.ai is a wholly owned subsidiary of Evergreen Wealth Corporation. Evergreen.ai is an artificial intelligence tool offered through Evergreen Wealth Corporation.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Evergreen Wealth Advisors does not share with nonaffiliates so they can market to you</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Evergreen Wealth Advisors doesn't jointly market</i>

Other important information
<p>This Privacy Notice applies to information we collect and share in connection with your financial accounts and services, as required by federal law. Evergreen Wealth Corporation also maintains a separate General Privacy Policy that explains how we handle information collected through our website, digital services, use of Artificial Intelligence, and marketing activities.</p> <p>Evergreen Wealth Corporation and Evergreen Wealth Advisors maintain separate but coordinated privacy notices. Together with Evergreen Wealth Corporation's General Privacy Policy (available in the Privacy section of our website), these documents explain how entities collect, use, and share personal information. We will provide you with our Privacy Notice annually for as long as you maintain an ongoing relationship with us.</p> <p>Evergreen Wealth Advisors retains client information only as long as necessary to provide services or as required by law, after which it is securely deleted or anonymized.</p> <p>Evergreen Wealth Advisors may change broker-dealers and/or custodians, and the nonpublic personal information collected by us may be provided to the new broker-dealers and/or custodians so we can continue to service your account(s).</p> <p>Do Not Call Policy. This notice is the Evergreen Wealth Advisors Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows. Evergreen Wealth Advisors employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from Evergreen Wealth Advisors will be placed on the Evergreen Wealth Advisors Do Not Call list and will not be called in future campaigns, including those of Evergreen Wealth Advisors' affiliates.</p> <p>Call Monitoring and Recording. If you communicate with us by telephone, we may monitor or record the call.</p>

California: Under California law, we will not share information we collect about you with companies outside of Evergreen Wealth Advisors, unless the law allows. For example, we may share information with your consent, to service your accounts, or to provide rewards or benefits you are entitled to. We will limit sharing among our companies to the extent required by California law.

Under the California Consumer Privacy Act (CCPA), as amended by the California Privacy Rights Act (CPRA), you have the right to:

- Request access to the personal information we collect about you;
- Request deletion or correction of your personal information;
- Opt out of the sale or sharing of your personal information;
- Not be discriminated against for exercising your privacy rights.
